In the event of such an injury, you may promptly report it to your supervisor and complete an Employee Accident Report Form. Should you need medical attention during the first (90) days, you are to receive it only from the list of approved centers and doctors below. We will not honor medical bills submitted from any center or hospital not on the approved list below. After (90) days of treatment, you may select any health care provider of your choice. However, you must advise your supervisor within 5 days of the first visit to each and every non-designated provider not listed below. Failure to do so may affect whether we are liable for payment rendered prior to appropriate notice. Should you have any questions, please see your supervisor. Thank you for your cooperation.
